Scope of Work

The scope includes collection and disposal of e-waste such as computers, laptops, printers, scanners, UPS, servers, networking equipment, and other electronic items in compliance with E-Waste (Management) Rules, 2016 and amendments thereof.

Eligibility Criteria

- Valid CPCB / SPCB Authorization Certificate issued under the E-Waste (Management) Rules, 2022.
- Authorization must clearly specify the category as Recycler / Dismantler / Refurbisher, as applicable.
- GST Registration Certificate (valid GSTIN).
- PAN Card of the firm.
- Undertaking on Firm's Letterhead confirming compliance with E-Waste Rules, validity of authorization, and non-subcontracting without APCOB approval.

Mandatory Certificates (After Lifting of E-Waste)

- Form-6 (E-Waste Manifest) duly filled and signed, as prescribed under the E-Waste (Management) Rules, 2022.
- E-Waste Collection & Recycling Certificate indicating item-wise / weight-wise details of e-waste lifted from APCOB.
- Final E-Waste Disposal / Recycling Certificate for statutory and audit compliance.
- Green Certificate certifying eco-friendly recycling and disposal of e-waste as per applicable environmental norms.

Terms and Conditions:

- The schedule and dates for lifting of e-waste shall be communicated to the successful bidder at least **seven (7) days in advance**.
- Packing, loading, transportation, and handling of e-waste from APCOB premises to the authorized recycling facility shall be the **sole responsibility of the successful bidder**, at their own cost and risk.
- All e-waste, data, and records of **The Andhra Pradesh State Cooperative Bank Limited** shall be treated as **strictly confidential**, and no information shall be accessed, copied, disclosed, or misused in any manner.
- All payments towards the value of e-waste shall be made **only in the name of The Andhra Pradesh State Cooperative Bank Limited (APCOB)**.
- Payment for the e-waste shall be made **within 5–6 working days** from the date of lifting and submission of all mandatory certificates, through **IMPS/NEFT/RTGS**.
- The bidder who **quotes the highest price** and **satisfies all eligibility criteria, statutory requirements, and tender conditions** shall be considered for award of the work.

- The successful bidder shall enter into a **Memorandum of Understanding (MoU)** with **The Andhra Pradesh State Cooperative Bank Limited (APCOB)** prior to commencement of e-waste lifting activities.
- APCOB reserves the right to accept or reject any or all bids, wholly or partly, without assigning any reason thereof.

Submission of Bids

Technical Bid:

1. Submit in a sealed envelope marked "**Technical Bid**".
2. Include compliance with eligible criteria mentioned.

Commercial Bid:

1. Submit in a separate sealed envelope marked "**Commercial Bid**".
2. Include price details and total cost.

Note:

1. Technical and Commercial Bids must be in separate envelopes.
2. **Only technically qualified bids** will move to the Commercial Bid opening.
