1. The bidder must be a Registered Company having operations for a minimum period of 3 years. Bidders may be MSMEs, Registered Firms, or LLCs.
2. The average annual financial turnover during the last 3 financial years (ending March 31, 2025) must not be less than INR 30 Lakhs.
3. The bidder must have a valid PAN number, GST Registration number, TIN, and CIN registered in the State of Andhra Pradesh.

Terms and Conditions:

- The tablet and laptop supplied shall be brand new, unused, and of latest manufacture.
- The quoted model must meet or exceed all the technical specifications mentioned in this tender
- Delivery of products should be within 7 days from the date of the Purchase Order.
- Payment will be made only after the successful delivery and Completion of Installation process of the product at the Bank's premises.
- **Delivery Challan** and **Installation Reports** must be submitted along with the products upon delivery
- Any repair/damage to the supplied hardware within the warranty period must be attended by the vendor.
- The Bank reserves the right to modify/amend/cancel the tender process or procurement without assigning any reason at any time.



- The warranty period for all hardware is 3 years for both Laptop and tablet, and support should be provided whenever the Bank raises a request.
- No additional charges will be paid outside the quoted price.
- Prices quoted shall be Exclusive of all taxes.

Submission of Bids

Technical Bid:

1. Submit in a sealed envelope marked "**Technical Bid**".
2. Include compliance with specifications, signed eligibility documents, and no pricing information.

Commercial Bid:

1. Submit in a separate sealed envelope marked "**Commercial Bid**".
2. Include price details and total cost.

1. Technical and Commercial Bids must be in separate envelopes.
2. **Only technically qualified bids** will move to the Commercial Bid opening.
