1. Eligibility Criteria

The bidder shall be a reputed manufacturer, authorized dealer, distributor, or supplier of Split ACs with experience in supply and installation of ACs to Banks, Government Institutions, Corporate Offices, or reputed organizations.

2. Submission of Bids

The bids shall be submitted in sealed cover superscribed as: **"Tender for Procurement of Split Air Conditioners for APCOB Head Office and Branches in Vijayawada & Guntur"** and addressed to the officer mentioned in the tender notice within the stipulated time.

3. Scope of Supply

The successful bidder shall supply and deliver Split ACs mentioned in the Tender Notice at the respective Offices/Branches.

The Bank reserves the right to split the order among multiple vendors.

4. Technical Specifications

All furniture items shall be of good quality, durable, and made from standard branded materials.

5. Brand Preference

The ACs Should be of Blue Star brand 2026 year Model.

6. Rates and Taxes

The quoted rates shall be inclusive of:

- Transportation
- Loading and unloading
- GST and all applicable taxes
- Any incidental expenses

No additional charges shall be payable by the Bank.

7. Validity of Rates

The rates quoted shall remain valid for a minimum period of 90 days from the date of opening of bids.

8. Delivery Period

The successful bidder shall complete supply within 07 days from the date of issue of Purchase Order or as directed by the Bank.

9. Warranty

The bidder shall provide a minimum warranty of:

- 1 year comprehensive warranty for Split AC
- 10 Years manufacturer warranty for Compressor.

12. Payment Terms

Payment shall be released after successful delivery, installation, and certification by the concerned officials of APCOB. No advance payment shall ordinarily be made.

13. Quality and Workmanship

The Bank reserves the right to reject any item found defective, substandard, damaged, or not conforming to the required specifications. The rejected items shall be replaced by the vendor at their own cost.

14. Bid Evaluation

The Bank may evaluate the bids based on:

- Competitive pricing
- Quality/specifications

- Brand offered
- Past performance
- Delivery capability
- Compliance with tender conditions

15. Right to Accept or Reject

APCOB reserves the right to accept or reject any or all bids, wholly or partly, without assigning any reason whatsoever. The Bank also reserves the right to cancel or modify the tender process at any stage.

16. Penalty for Delay

In case of delay in supply or installation beyond the stipulated period, the Bank reserves the right to impose penalty and/or cancel the order.

17. No Commitment

Issuance of this tender does not constitute any commitment on the part of the Bank to place an order with any bidder.

18. Dispute Resolution

Any dispute arising out of this tender shall be subject to the jurisdiction of courts at Vijayawada only.

Incomplete bids, conditional bids, or bids received after the due date and time shall be liable for rejection.
